- 04/19/20 – Coronation Feast at Vine and Sparrow at 5:00. Girls should be there by 4:30 for headshots and overview. Full costume. Tickets are \$20/adult, \$15 for under 12. 1 complimentary ticket provided per court family and court is covered. For ticket purchases visit Robin Hood Festival Website. **Mandatory attendance of court member.**
- 04/26/20 – Second Court meeting at 3:00 at 17671 SW Nels Drive. **Mandatory attendance of 1 parent and court member.**

June

- 06/02/20 - Presentation of court to Sherwood City Council at 7:00. Please meet at the Sherwood Public Library at 6:45 in full costume. **mandatory attendance**
- 06/07/20 – Oregon Renaissance Faire. We will go as a group with girls in full costume. Time TBD

July

- 07/04/20 – July 4th Parade in Hillsboro **mandatory attendance of parents and court.** The court and their families will be required to meet at our outdoor storage shed at 7:00 in full costume, and drive as a group together into Hillsboro to stage for the parade. Expect to be busy until 1:00 with tear down and return of float.
- 07/14-07/19 – Robin Hood Festival week **mandatory attendance of parents and court.** Families will be busy the entire week of the festival as the girls and their families are asked to help set up the festival and the girls participate in a number of activities, and media opportunities during that whole week.
- 07/16/20 – Bilingual Story Time at Stella Olsen park at 11:00. Full costume and **mandatory attendance.** After Storytime, we will go to the library to judge the Castle contest. Expect to be done around 1:30.
- 07/16 or 17 – Expect an early morning news broadcast from Veterans park. Court in full costume
- 07/17/20 – Hair appointment for appearances in Robin Hood Festival. 3:00 on Festival grounds
- 07/17/20 – Knighting Ceremony in old town at 5:30. **Mandatory attendance of court and families in full costume**
- 07/18/20 – Archery opening ceremony at Laurel Ridge – 8:00am. Expect to be busy all day with the Archery tournament, parade, MCing of the family stage in old town, Maid Marian meet and greet tent and being ambassadors for Sherwood and the Robin Hood Festival. **Mandatory attendance of court and families in full costume**

- 11/23/20 – Stuffing Santa bags for tree lighting ceremony at the Masonic Lodge– time TBD

December

- 12/05/20 – Sherwood's Old Town Parade and Christmas tree lighting ceremony **mandatory attendance of parents and court.** Court families help with set up of Christmas tree lighting and float construction. This is the last time that the girls will perform community service as a group and they required to attend. Senior Court will be MCing the Christmas tree lighting, and the Junior Court will be Elves, helping Santa. They will all be doing public speaking.
- 12/12/20 – Christmas Tea and buddy gift exchange at Kristine's house. Time TBD.
